Terms and Conditions

Effective as of October 14, 2021

PLEASE READ THESE TERMS CAREFULLY AND IN FULL. THEY CONTAIN CERTAIN CONDITIONS AND RESTRICTIONS ON THE AVAILABILITY AND USE OF THIS SPOTIFY PREMIUM CAR THING OFFER INCLUDING INFORMATION ON THE PROCESS AND TERMS AND CONDITIONS THAT APPLY TO REDEMPTION AND PURCHASE OF A CAR THING DEVICE ON THE CAR THING STORE.

When redeeming a device you will be directed to the Car Thing store at carthing.fromspotify.com (“Car Thing Store”) and purchase the device directly from Luzern Solutions Limited (“Luzern”). Luzern, not Spotify, is responsible for acceptance and fulfilment of Car Thing purchases.

1. Introduction.

This Spotify Premium Car Thing Offer (the “**Car Thing Offer**”) is made available by Spotify (as defined in the [Spotify Terms and Conditions of Use](#) (“**Spotify Terms of Use**”) and is subject to these terms and conditions (the “**Car Thing Offer Terms**”). These Car Thing Offer Terms supplement and incorporate by reference the Spotify Terms of Use. Some Premium subscriptions are subject to additional terms and conditions as referenced below:

- (A) in the case of Premium Family: the [Premium Family Terms and Conditions](#) (the “**Premium Family Offer Terms**”);
- (B) in the case of Premium Duo: the [Premium Duo Terms and Conditions](#) (the “**Premium Duo Offer Terms**”);
- (C) in the case of Premium Student: the [Premium Student Terms and Conditions](#) (the “**Premium Student Offer Terms**”).

If there is any inconsistency between these Car Thing Offer Terms and the Spotify Terms of Use; the Premium Family Offer Terms; the Premium Duo Offer Terms; or the Premium Student Offer Terms (as applicable), these Car Thing Offer Terms will prevail. Relevant references to “Paid Subscriptions” in the Spotify Terms of Use; to the “Premium Family Subscription” in the Premium Family Offer Terms, to the “Premium Duo Subscription” in the Premium Duo Offer Terms and to the “Premium for Students Subscription” in the Premium Student Offer Terms shall be read to apply also to this Car Thing Offer where relevant and permitted by these Car Thing Offer Terms.

2. The offer.

Eligible Users (as defined below) are entitled, subject to these Car Thing Offer Terms, to redeem a Car Thing device (a “**Car Thing**”) on the Car Thing Store. To do so, Eligible Users must purchase a Car Thing at the advertised purchase price from Luzern. **Luzern and not Spotify, is responsible for the acceptance and fulfilment of purchases for each Car Thing and separate terms and conditions made available by Luzern apply to each purchase made.** Information on the features and operating requirements of a Car Thing is provided on the Car Thing Store. Only one Car Thing Offer may be redeemed by each Eligible Users. Each Car Thing Offer is personal and can not be transferred.

3. Duration.

This Car Thing Offer is supply limited. The Car Thing Offer shall end automatically and no longer be available for redemption and purchase on the earliest of:

- (A) supplies of Car Thing devices run out; or
- (B) this Car Thing Offer being terminated by Spotify.

To the fullest extent permitted by applicable law, Spotify reserves the right to modify or terminate this Car Thing Offer at any time and for any reason. Spotify shall not be obligated to permit any further attempts to take up this offer after it has ended. In particular, we may limit eligibility and/or duration to prevent abuse of this Car Thing Offer.

4. Eligibility.

Car Thing requires a Spotify Premium subscription plan in order to work (not included in the purchase price of Car Thing).

To receive this Car Thing Offer and be able to purchase a Car Thing, users must satisfy all of the conditions listed in 4(A)-(B) below (each an “**Eligible User**”):

(A) You must be - or sign up to become - a Qualifying Plan User, where “**Qualifying Plan User**” means

(x) either a user of the Free version of the Spotify service in the USA, or

(y) a current, paying subscriber in the USA to one of the following forms of Spotify Premium (a type of Paid Subscription):

(i) [Premium Individual](#);

(ii) [Premium Family](#) (including both the primary account holder and sub-account holders);

(iii) [Premium Duo](#) (including both the primary account holder and the sub-account holder); or

(iv) [Premium Student](#).

By registering your interest to purchase a Car Thing, you (i) accept this Car Thing Offer and (ii) acknowledge and agree to these Car Thing Offer Terms.

(B) You must have received an email directly from Spotify stating that you are eligible to purchase a Car Thing. This offer is personal and non-transferrable.

5. Redemption.

To purchase a Car Thing, you must affirmatively take certain steps to redeem your offer and purchase the Car Thing device on the Car Thing Store - it will not happen automatically.

After you have received an email from Spotify stating that you are eligible to purchase a Car Thing, you must follow the steps in the email that we send to you. Upon clicking on the email, you will be directed to the Car Thing Store where you may redeem and pay the purchase price for your Car Thing. If you navigate away from the Car Thing Store before completing checkout your offer will not have been redeemed.

6. Fulfilment and shipping of Car Things.

Fulfilment and shipping of all Car Things is undertaken by Luzern, not Spotify.

Fulfilment: To redeem your offer on the Car Thing Store, you must visit [Carthing.fromspotify.com](https://carthing.fromspotify.com) and pay the advertised purchase price. You must add the Car Thing to your cart and enter a form of payment approved by Luzern. **Use of the Car Thing Store will be subject to the terms and conditions made available by Luzern on the Car Thing Store, including [Luzern's Terms of Sale](#).** Offers are non-transferable and may not be exchanged or returned for cash or used for any other product or service.

Shipping: Car Thing can only be shipped within the United States. Standard shipping is included in the purchase price. However, supplementary shipping options may be available, in which case any applicable shipping charges will be displayed to you prior to checkout on the Car Thing Store.
